




TECHNICAL DATA:

Fixture is designed to be installed on a finished wall and serviced from an accessible pipe chase. Fixture is fabricated from 14 gage, type 304 stainless steel with an enclosed bottom and is seamless welded construction. Exterior has a satin finish.

Rectangular lavatory bowl is 14" x 12" x 4" deep and includes a self-draining soap dish and an integral fast drain. Standard elbow waste outlet is 1-1/2" O.D. plain end and extends 6" beyond the rear of fixture

Lavatory valve is an Air-Control, pneumatically operated pushbutton valve using atmospheric air and includes a 0.5 GPM flow control. Valve is metering, non-hold open type with spout and conforms to lead free requirements of NSF61, Section 9, 1997 and CHSC 116875. Valve can be remotely located up to 10 feet from operating pushbutton. Pushbutton is vandal resistant and requires less than 5 lbs. pressure to actuate valve. Timing is adjustable from 5 to 60 seconds.

Lavatory will meet national ADA requirements when installed with rim at 34" above floor.

Regularly furnished items include valve, pushbutton assembly, deck mounted spout, mounting hardware for walls up to 8" thick, thru wall waste and 1-1/2" tubular P-trap behind the wall.
