**Ligature Resistant Siphon Jet Replacement Toilet** is arranged to be installed against a finished wall from the front side to an existing In-Wall Mounting Carrier Support with (4) Bolt Pattern. Fixture is designed to replace Wall Hung Toilets that were previously installed with a Mounting Carrier Support. Replacement Toilet uses the existing 5/8" UNC Carrier Studs to mount unit to wall while being supported by the on-floor Housing. Unit includes Access Panels on both sides to facilitate installation. Unit is fabricated from 16 gage type 304 stainless steel and is seamless welded construction with exterior surfaces powder coated white (interior of toilet will have a satin finish and will not be powder coated). Toilet will be provided with WH-LRSC-GRAY Ligature Resistant ABS Toilet Seat Cover.

**Toilet** is siphon jet type with an elongated bowl manufactured to comply with ASME A112.19.3, CSA B45.4 and 2010 ADA Standards for Accessible Design. Toilet requires a minimum of 25 PSI flow pressure and uses a minimum water consumption of 1.28 GPF. On-floor units can withstand load rating of 5000 lbs. without permanent damage. Trap has a minimum 3-1/2" seal, will pass a 2-1/8" ball and is fully enclosed. Toilet has a 1-1/2" NPT

flushing inlet connection. Wall waste outlet connection is a 5-1/2" recessed gasket flange to make up connection with existing Carrier.

**Flush Valves, Top Supply Covers and Wall Supply Access Panels** are optionally available for all styles of Toilets and may be specified separately.

Provide and install Whitehall Best-Care™ Ligature Resistant ADA 2010 Compliant Replacement Toilet (specify model number and options) intended for use with existing In-Wall Mounting Carrier Support with (4) Bolt Pattern. Fixture shall be fabricated from 16 gauge type 304 stainless steel. On-floor units can withstand load rating of 5000 lbs. without permanent damage. Construction shall be seamless welded and outside surfaces are powder coated white. Housing to include side access panels to facilitate installation. Toilet shall be concealed siphon jet type with an elongated bowl and self-draining flushing rim. Toilet shall be ASME A112.19.3, CSA B45.4 and 2010 ADA compliant. Toilet requires a minimum of 25 PSI flow pressure and uses a minimum water consumption of 1.28 GPF. Toilet trap shall have a minimum 3-1/2" seal and shall pass a 2-1/8" diameter ball and is fully enclosed. Provided with WH-LRSC-GRAY Ligature Resistant ABS Toilet Seat Cover.










