


A—ROUGH-IN FOR THE FOLLOWING:



- 5-1/2" DIAMETER RECESSED GASKET FLANGE ①.
- FLUSH VALVE INLET 1" NPT ②.
- FIXTURE FLUSHING INLET 1-1/2" NPT ③.

B—OPTIONAL FLUSH VALVE ACCESS PANEL ④ FOR BACK SUPPLY FLUSH VALVES SHOWN FOR REFERENCE ONLY.

C—UNITS LESS CARRIER: ON FIXTURE SIDE OF REINFORCED WALL, INSTALL WALL ANCHORS BY OTHERS MATCHING MOUNTING LOCATIONS AS INDICATED. SECURE MOUNTING CHANNEL ⑤ TO WALL WITH INSTALLER PROVIDED HARDWARE.

D—UNITS WITH CARRIER LEGS: FOLLOW MANUFACTURER'S INSTALLATION REQUIREMENTS FOR YOUR CARRIER ⑥. SECURE MOUNTING CHANNEL ⑤ TO CARRIER WITH ANCHORING HARDWARE PROVIDED WITH YOUR CARRIER. SEE DETAIL A-A.

E—REMOVE ACCESS PANELS ⑦ AND SET ASIDE. WHILE HOLDING INSTALLER PROVIDED WASTE GASKET IN PLACE, ALIGN WASTE OUTLET CONNECTIONS & SECURE FIXTURE HOUSING TO MOUNTING CHANNEL LOOSELY WITH 1/4-20 SCREWS ⑧ PROVIDED.

F—TIGHTEN WASTE CONNECTIONS THRU ACCESS OPENINGS AND REPLACE ACCESS PANELS ⑦.

G—TIGHTEN 1/4-20 SCREWS ⑧ SECURING FIXTURE TO MOUNTING CHANNEL ⑤. SEE DETAIL B-B.

H—FOR OPTIONAL -FV FLUSH VALVE: CONNECT FLUSH ⑨ AS REQUIRED FOR CONCEALED INSTALLATIONS PER MANUFACTURER'S RECOMMENDATIONS.

NOTE: FOR -ADA UNITS REFER TO ADA ACCESSIBILITY GUIDELINES FOR COMPLETE INSTALLATION REQUIREMENTS.

1—ALL VERTICAL DIMENSIONS INDICATED** INCREASE PROPORTIONATELY WITH ADA SEAT HEIGHT: FOR ADA 18" SEAT HEIGHT, WASTE OUTLET BECOMES 8-1/2".

2—FLUSH VALVE MUST BE HYDRAULICALLY ACTUATED OR SUPPLIED WITH AN ADA HANDLE. MAX CONTROL HEIGHT IS 44" ABOVE FINISHED FLOOR.
