Whitehall BestCare® Solid Surface Toilet is designed to foster a peaceful, well-balanced environment, combining a stylish, sleek appearance with enhanced patient safety. Its Universal Design supports ligature resistance, ADA accessibility, accommodation for individuals of size, and traditional restroom applications. Unit is engineered to allow retrofit to existing Toilet Waste rough-ins, providing labor savings and ease of installation for renovation.

On-Floor Toilet is designed for installation against a finished Wall from the Fixture side, utilizing a concealed Wall Mounting Channel. The Bowl interior is rimless to allow easier, more sanitary cleaning while eliminating ligature points for wedging objects. Its unique Flushing Rim design delivers a full 360-degree rinse to wash down the Bowl interior. Vandal-Resistant exposed Fasteners are included to complete the Assembly. Wall Mounting Hardware is provided by the Installer to suit site conditions.

Toilet Housing, Bowl and Seat are constructed of Corterra® Solid Surface Polymer Resin, which is GREENGUARD® Gold listed, WaterSense® Certified and conforms with ANSI Z124.3, ANSI Z124.6, and ANSI/ICPA SS-1 standards. Toilet Bowl color furnished is Blanco OCC11 (Glossy White).

Integral Toilet Seat features contrasting color to enhance visibility and assist users with cognitive impairment. Seat color is -OCC21 Moonstone Metallic (Gray Gloss) and optionally available in -OCC11 Blanco (Glossy White) to match Toilet Bowl.

Static load rating for the On-Floor Bowl is IAPMO Certified to withstand 25,000 lbs. [11,340 kg] without permanent damage, providing exceptional vandal resistance and long-term durability for demanding environments.

Toilet P-trap and Blowout Jet Fittings are fabricated of type 304 stainless steel and allow for Customer specified Wall or Floor Waste Outlet dimensions.

Toilet is siphon jet type with an elongated Bowl conforms with ASME A112.19.3, CSA B45.4 and ADA Standards for Accessible Design. Toilet requires a minimum of 25 PSI flow pressure and will operate with a minimum water consumption of 1.28 GPF (4.8L). P-trap has a minimum 3-1/2" seal, and will pass a 2-1/8" ball.

Toilet Waste Outlet connection is offered for Wall or Floor Waste and includes a Recessed Gasket Flange to make up connection with Industry Standard Closet Flange.

Toilet Top Supply Inlet includes a 1-1/2" NPT male Flushing Inlet connection for Top (Exposed) Flush Valve supply.

Optional Flush Valve Covers are available in complementary finishes for Top Supply models and shall be specified separately to suit the application. Note: Concealed In-Wall Flush Valves are recommended for Ligature-Resistant ADA applications to ensure adequate spacing for Closure-Type Grab Bar designs.

Optional Hinged Toilet Seats are offered for traditional settings or the unit may be Factory drilled for a Hinged Seat to be provided by others.

Important: Hinged Toilet Seats present a ligature risk and should not be used in Behavioral Health settings.
