Ligature Resistant Corterra® Alcove Basin is engineered to combine the look and feel of commercial grade designer Countertops with safety, durability and aesthetics in mind. The Alcove Countertop consists of a one piece, solid surface Deck with an integral basin offered in a variety of shapes and sizes. Dimensions for Deck width, Basin design along with Faucet and Backsplash options are specified to create a unique Ligature Resistant Lavatory System. Standard height units comply with ANSI, UFAS, and ADA requirements. (Compliance is subject to the interpretation and requirements of the local code authority.) Countertops are subject to certain minimum and maximum dimensional criteria as a result of Accessibility Guidelines and Factory limits for manufacturing.

Note: Provide finished Wall dimensions. Factory will design custom product with applied tolerances to allow for ease of installation. Caulking material (provided by others) will be required to ensure no voids along walls are present following installation.

Countertop and Integral Basins are constructed of Corterra® Solid Surface Polymer Resin and conform with ANSI Z124.3, ANSI Z124.6 and are ANSI/ICPA SS-1 compliant. (Greenguard Gold listing is pending.) Stainless Steel Frame provides rigid support for Countertop.

Standard Countertop color furnished is Blanco Matte OCC11M (White). Countertops are offered with optional Corterra colors. Refer to Link for available colors:

Standard Basin color furnished matches Countertop however, when Premium Corterra® Colors are specified, Basins will be provided with Blanco (Glossy) OCC11 color.

Basin includes ligature resistant Drain Fitting with Grid Strainer and air vent grid at rear of Basin for optimal drainage. Waste outlet is optionally available with individual 1-1/2" P-Traps. Backsplash and side splashes (3" high) are optionally available and shipped loose for field mounting.

Bottom Enclosure conceals P-trap and waste piping, mounting and valve assemblies, and is fabricated 16 gauge, type 304 stainless steel with exposed surfaces EG-10 Enviroglaze® Powder Coated White. Enclosure remains closed using vandal resistant fasteners. Front Access Plate pivots to fully open and allow access to complete installation.

Note: Bottom Enclosure maximum width is 48". Alcove widths greater than 48" will receive additional Bottom Enclosure Section(s). Overall width and placement of Lavatory Basin is subject to Factory approval.

Unit with 34" standard rim height shall conform with ANSI, UFAS and ADA Accessibility Standards. Provide integral Basin [Specify Basin type] with ligature resistant Drain Fitting. Countertop, [Specify optional Backsplash and Side Splashes] to be constructed of Corterra® Solid Surface Polymer Resin. Corterra® Solid Surface color shall be [Specify]. Alcove Lavatory System shall conform to ANSI Z124.3 and ANSI Z124.6 and shall be ANSI/ICPA SS-1 compliant. Bottom Enclosure shall be constructed of 16 gauge, type 304 stainless steel with exposed surfaces Powder Coated White. Removable Bottom Access Panel shall be secured with Vandal Resistant Fasteners.




-BBED SLOPED BASIN





One Station Alcove Basin




