Straddle Blowout Jet Urinal - Replacement - ADA Compliant

Acorn 3349 Straddle Blowout Jet Urinal is designed to replace Aluminum Plumbing Fixture Corp. (Super Secur) Model A-600.

Fixture is arranged to be installed on a finished wall and serviced from the front side. Fixture and rough-in adapter box are fabricated from 14 gage, type 304 stainless steel and are seamless welded construction. Exterior has a satin finish. Interior has a matte finish. Fixture has a back wall washdown and is optionally available with a continuous flushing rim, which allows for washing all four walls. Corners are coved to facilitate cleaning. P-trap is fully enclosed. Back of fixture is sound-deadened with fire resistant material. Units conform with ANSI, UFAS and ADA requirements for accessibility. Compliance is subject to the interpretation and requirements of the local code authority.

Urinal is blowout jet type with back wall washdown. Flushing inlet connection is 1-1/2" NPT male and requires a minimum of 25 PSI flow pressure. Trap has a minimum 2-1/2" seal and will pass a 1.9" ball. Waste connection is Gasketed Waste.

Exposed mounting screws are furnished. No concealed wall fasteners are furnished.

GUIDE SPECIFICATION Provide and install Acorn Replace-Ware Straddle Blowout Jet Urinal (specify model number and options). Urinal shall be back wall washdown type. Fixture shall be 14 gage, type 304 stainless steel. Urinal shall have coved corners to facilitate cleaning. All welds shall be continuous and exterior surfaces shall have a satin finish. P-trap shall be fully enclosed and pass a 1.9" diameter ball. Waste connection shall be Gasketed Waste. Fixture shall be furnished with exposed mounting screws. Units to conform with ANSI, UFAS and ADA requirements for accessibility.

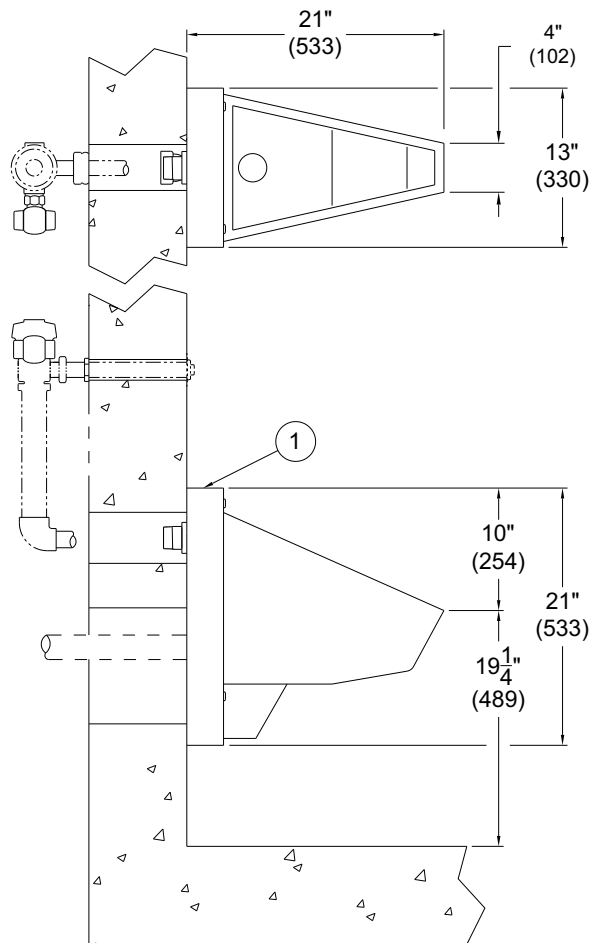

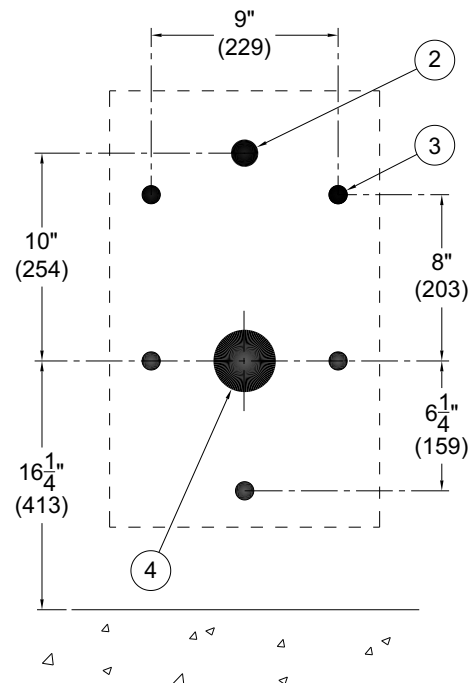
