



INSTALLATION INSTRUCTIONS

A-ROUGH-IN FOR THE FOLLOWING.

- 7-1/2" RECESSED GASKET FLANGE (1)
- FLUSH VALVE INLET 1" NPT (2)
- -W OR -T FIXTURE FLUSHING INLET 1-1/2" NPT (3)

B-FLOOR WASTE CONNECTION COMPARABLE TO CHINA UNITS. THE FLOOR WASTE CLOSET FLANGE (BY OTHERS) CENTERLINE SHOULD BE 12" ±1/8" FROM FINISHED WALL AND FLUSH WITH THE FINISHED FLOOR.

C-FLANGE MOUNTING BOLTS (4) (BY OTHERS) MUST BE 1" MAXIMUM ABOVE THE FINISHED FLOOR LEVEL.

D-PRESS FLANGE SEALING GASKET (BY OTHERS) IN PLACE. SET TOILET OVER WASTE FLANGE ENSURING MOUNTING BOLTS (4) GO THRU HOLES IN TOILET BASE FLANGE (1).

E-ENSURE TOILET IS PERPENDICULAR TO WALL. APPLY EVEN PRESSURE ALL AROUND TOILET TO ENSURE PROPER SEAL. ANCHOR BASE TO WASTE FLANGE WITH NUTS (5) PROVIDED.

F-ANCHOR TOILET HOUSING TO THE WALL AT SLOTS (6) USING ANCHORS AND FASTENERS BY OTHERS.

G-CONNECT FLUSH VALVE AS REQUIRED FOR CONCEALED -W WALL SUPPLY (7) OR EXPOSED -T TOP SUPPLY (8) INSTALLATION PER MANUFACTURERS' RECOMMENDATIONS.

NOTES:

FOR SUFFIX OPTION -ADA UNITS, REFER TO ADA ACCESSIBILITY GUIDELINES FOR COMPLETE INSTALLATION REQUIREMENTS.

1-ALL VERTICAL DIMENSIONS CHANGE ACCORDING TO ADDITIONAL SEAT HEIGHT FOR -ADA I.E. FOR 17" INTEGRAL SEAT HEIGHT, -W FLUSHING INLET BECOMES 15-1/4".

2-FLUSH VALVE MUST BE HYDRAULICALLY ACTUATED OR SUPPLIED WITH AN -ADA HANDLE, MAX. CONTROL HEIGHT IS 44" ABOVE FINISHED FLOOR. CONTROLS MUST LOCATED WIDE SIDE TOILET.
