


NOTE: Grate Locking Bars Should Be Located Away From Over The Outlet. Outlet Opening Must Be Clear Of Obstructions.

Fabricated 14 Ga Type 304 Stainless Steel Body with Integral Anchor Flange, Vandal Proof Stainless Steel Perforated Grate and 2" NO-Hub Bottom Outlet. Grate has .25(6) Dia Perforations.




OPTIONAL TILE INLAY GRATE -TIG
