

SUGGESTED SPECIFICATIONS

Model A181400S-CUSP is a fully recessed, wall mounted drinking fountain and cuspidor made from 18 gage, 304 stainless steel with a brushed finish. Each unit shall be activated by a surface mounted, chrome plated brass front pushbutton using less than 5 pounds of force. Bubbler shall be Stainless Steel, with an integrally designed non-squirt feature and operates on a water pressure range of 20-105 psig. Unit shall be certified to Public Law 111-380 (NO-LEAD) and NSF/ANSI/CAN 61. Fixture meets ADA, ADA Standing Person, and ADA Child requirements when mounted appropriately. Optional WF3000 PFAS Water Filter shall have 3000 gallon capacity with 3rd Party Certification for Lead, Bacteria, Chlorine, Microplastics, and NSF/ANSI for Cyst and total PFAS reduction.


